We are excited to announce that SoliMarket has been selected as WIC's FMNP electronic-solution provider.

SoliMarket provides a SHOPPER app for WIC participants and a REGISTER app for NV FMNP approved farmers. A card is also available for participants who do not have smart phone technology or prefer a card.

The SoliMarket Register for farm cashiers support both iOS & Android phones and tablets. It is available on the Apple store or Google Play. It is free to download and free to use.

Training will be provided to farmers to ensure a smooth transition. Contact us if you do not have the technology or have connectivity issues for assistance.

Features

- Multiple Farm Cashiers

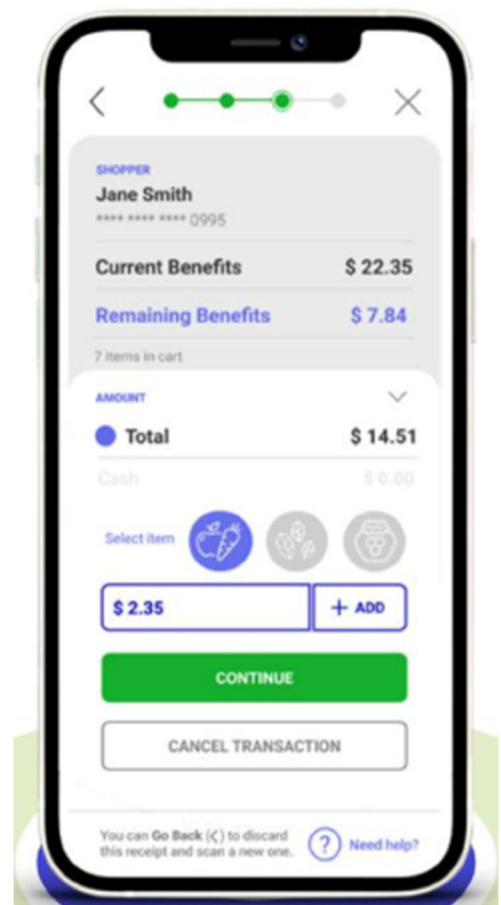
The SoliMarket Register application supports multiple farm cashiers who can make sales at the same time for the same farm account.

- Sales History

Sales made are digitally signed and recorded into the application for review and reporting.

- Payments

Payments will be automatically direct deposited into farm bank accounts roughly every other week.

Farmer Applications

- Farmer applications will be available in June 12th. The Farmer Agreement will be included in the application. Please read the agreement. By signing, you acknowledge that you read and understand the agreement and sanction table.
- Applications will be available on the [NV WIC Farmers Market website](#) and also emailed to all farmers previously active in the program.
- Only one application is needed per farmer.
- All applications will need to be emailed back to us or completed and digitally signed promptly for processing.
- Once farmers are approved we will send out a link to the **REQUIRED** farmer training which will be conducted via TEAMS.
